Sir/Madam,

In reference to Medical Assessment and Rating Board for Homoeopathy (MARBH) letter No. F. No. 4-7/2026-27/NCH (MARBH)/ (118-02) dated 15.07.2026, Lord Mahavira Homoeopathic Medical College, Dr. Hahnemann Chowk, Kitchlu Nagar, Civil lines, Ludhiana- 141001 has filed an appeal to the Commission against the decision of MARBH vide letter no. LMH/2026/265 dated 10.08.2026.

Commission has directed MARBH vide letter no. F. No. 30-5/2026-27/NCH-GR (37)/13207 dated 16.09.2026 for the issuance of permission to Lord Mahavira Homoeopathic Medical College, Dr. Hahnemann Chowk, Kitchlu Nagar, Civil lines, Ludhiana- 141001 with intake capacity of 30 seats (reduced from 50 seats). Accordingly, **MARBH is granting permission to college for 30 seats (reduced from 50 seats) for BHMS course for the academic year 2026-27.**

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of UG seats shall be treated as All India Quota. Counselling for seats under all India quota shall be conducted by respective Counselling Authority of State/UT Government as designated by Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the state/UT Government.

The Category-wise list of the selected candidates may be informed to the Medical Assessment and Rating Board after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

If aggrieved by the above decision, the college may, as per sub-section (6) of Section 9 of the NCH Act, 2020, prefer a second appeal to the Central Government addressed to the Secretary, Ministry of Ayush, Ayush Bhawan, B Block, GPO Complex INA, New Delhi – 110023 within 15 days from the issuance of this communication through the designated e-mail ID i.e., secondappeal-moa@gov.in, and a hard copy of the same email shall also be submitted to the Ministry of Ayush
